- Equipment:

- Registration & fee collection:

 - Over 40 and 48 at \$275
 - U21 at \$350
 - 2 leagues is a combined fee of \$450.
 - Women's Fees:
 - Div 1 and Div 3 at \$325
 - Div 2 at \$300, over 30 at \$300
 - All fees to be paid a.s.a.p. and all at once. Fees can be paid by e-transfer, cheque or cash. E-transfer to: treasurer@vicwestsoccer.com
 - Security question "What's our home field?" Answer="Finlayson".
 - Registration: Carmen has filled the role as "Registrar". Will work with treasurer to ensure that all fees are paid, etc.
 - Please check our website and your league website to ensure your team's contact info is correct and up to date
 - Every team needs to send their scores, scorers names & a match report (optional).... to Andy Teppin scores@vicwestsoccer.com - so he can update our website
 - New teams added this year:
 - U21 Men team coached by Dave H.
 - Div 2 Women coached by Andy and Cisco.
 - Div 1 Women coached by Casey
 - Trying to schedule all the new teams to the field is a work in progress.

- Registration: the same excel sheet as previous may be used regarding player names, numbers, etc. Encouraged that any information should be given to Carmen immediately. Garry noted that this should be submitted more than 24 hours before game day as per the rules/regulations.
- o Mark: If new men players are transferring from other clubs then have to follow what VISL requests regarding name, address, etc to get player number so that the coach can access the player info in order to apply for a player ID card.
- Women start playing Sept 8 weekend.
- o Men start playing also Sept 8 weekend.
- o 1 coach per team gets free dues but if not using it can disperse the amount to a player such as team manager or whoever is struggling to pay their dues.

• VISL information:

- VISL "Season start meeting" is scheduled for August 21st at 7pm. Reps from each team attend including Registrar.
- O VISL has an extensive handbook online to read and avoid fines. For example: getting scores in on time after games. Getting electronic IDs at start of game you can submit "apparently" in case you don't have actual player cards available.
